- c) If the student fails to obey or act in accordance with NUST's Rules/Regulations.
- d) If the student is punished because of his involvement in violation of the university rules, damages to institute property, misbehavior with staff or colleagues or any other disciplinary action.
- e) If the student fails to maintain academic standards of the university (standards in general and those particular to this scholarship and issued separately).
- f) If the information provided by the student is found incorrect or false any time during his study period, he may be penalized, which may result into cancellation of his admission.
