BUILDING ACADEMIC LINKAGES

Between

Pakistan Microfinance Network (PMN)

And

NUST Business School (NBS)
at Kashmir Highway, Sector: H 12, Islamabad

This MOU witnesseth as follows:

PMN and NBS agree to collaborate under the Network's **Academic Linkages** program with effect from **May 1, 2010**.

PMN will make the following contributions to this effort between the two institutions, and will be responsible for building links with Career Services and Placement Office and Office of Head of School/Department:

PMN's collaborative role will consist of:

- Collection of information from its members about projects, researches, and other positions and/or opportunities that may be of interest to the students of NBS. These positions/opportunities may make internships and projects subject to availability;
- Scheduling industry guest speaker sessions in coordination with NBS;
- Sharing industry information material, including but not limited to PMN quarterly, annual, and occasional publications as per PMN discretion;
- Coordination of and at career fairs/presentation sessions/events focused on microfinance and industry awareness building;

- Sharing a detailed internship program and coordinating internships starting 2010; and
- Inviting the relevant Head of Department and/or faculty from NBS to PMN roundtables/research dissemination forums.

NBS's collaborative role will consist of:

- Placement of PMN on the NBS Student Affairs Office - Industry Contacts Panel;
- Allowing microfinance material to be displayed and distributed on campus;
- Informing PMN about career fairs/events specifically dates, details and logistics, with sufficient notice to facilitate PMN participation;
- Informing PMN about internship and employment applicants;
- Coordination with PMN when scheduling guest speakers; and
- Appointment of interested faculty and relevant Head of Department(s) to participate at industry forums organized by PMN.

This collaboration may extend to any other area that PMN and NBS wish to add to this document, subject to the mutual consent of both parties.

This MOU will remain valid from the date first given above up to December 2012 and may be extended further thereafter with mutual consent.

Either signatory to this MOU reserves the right to terminate this MOU by giving 30 days notice in writing to the other party.


