

GENERAL INSTRUCTIONS
INTER SCHOOL FOOTBALL (MEN) & FUTSAL (WOMEN COMPETITION- 2022/23)

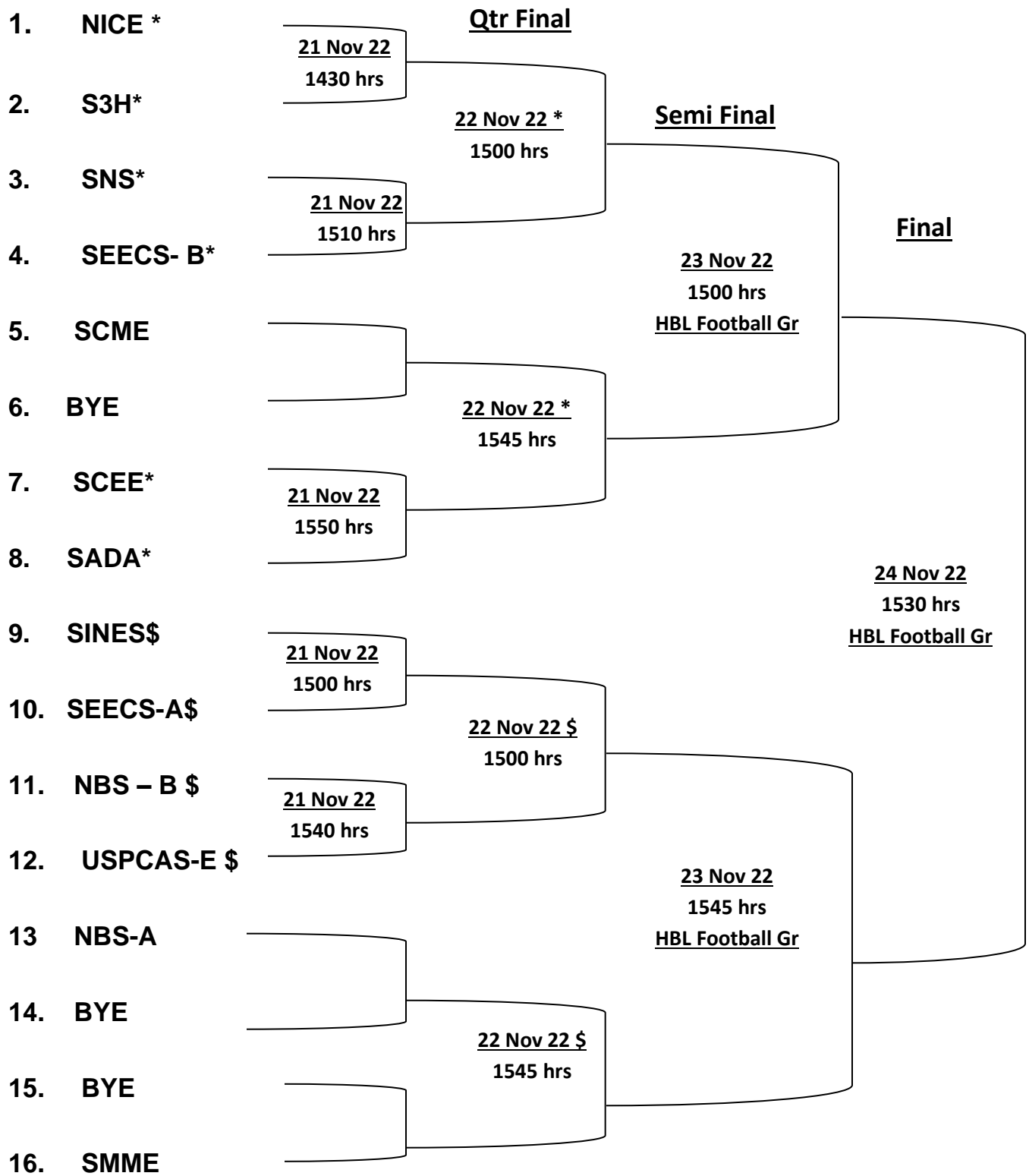
1. All matches will be played on knock out basis, Men matches at New Sports Complex Football ground, Adm HBL Football ground and Women at C1- Futsal ground.
 2. All team managers /sports officers are responsible of their team discipline. Presence of team managers /sports officers is mandatory during competition.
 3. The competition will start as per schedule attached and all teams must report at venue 15 minutes prior given time for the start of match.
 4. Team will be disqualified if not arrived within 5 minutes after given time for the start of match. Incomplete team will be disqualified.
 5. Football (Men) team will be comprised of maximum 16 x players and minimum 11 players and Futsal (Women) team will be comprised of maximum 10x players and minimum 7x players as per PUSB rules only under 25 PG/UG students are eligible to compete. Teams SINES and USPCAS-E will be allowed over 25 as a one time measure. All team manager/sports officers will submit list of team duly signed before the start of tournament.
 6. All Football (Men) played for included final match will be played of 35 minutes with two half. Each half will be 15 minutes with 5 minutes break.
 7. All Futsal (Women) matches included final match will be played of 25 minutes with two half. Each half will be played for 10 minutes with 5 minutes break.
 8. Players must wear proper sports kits (Trouser, T -Shirt & Joggers for women and short, T- Shirt & jogger for Men) no Shalwar Qamez or any other dress is allowed. Bibs will be made available for all teams before start of each match.
 9. One Student can participate maximum in three sports 1x Indl Sports & 2x Team Sports (List att). If any team found violation of this rule will be disqualified.
 10. Trophies will be handed over through vouchers.
 11. Referees decision will be final.
 12. Protest must be submitted in writing alongwith fee Rs 1000.00 (nonrefundable) within 15 minutes of termination of match. If the protest is valid and accepted, 50% of the fee will be refunded.
 13. Protest if any launched, will be settled by the Jury of appeal at any stage during the course of competition.

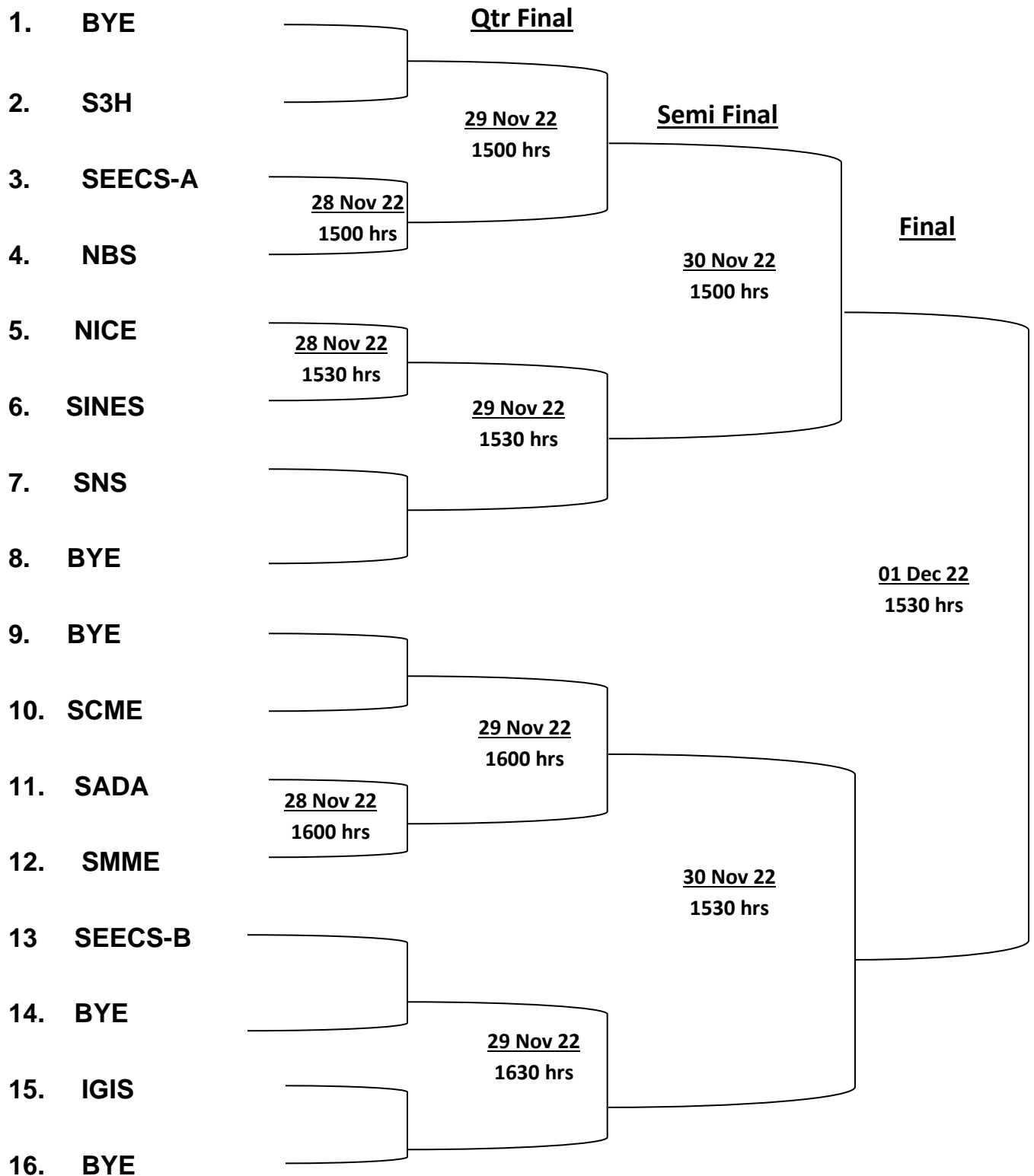
