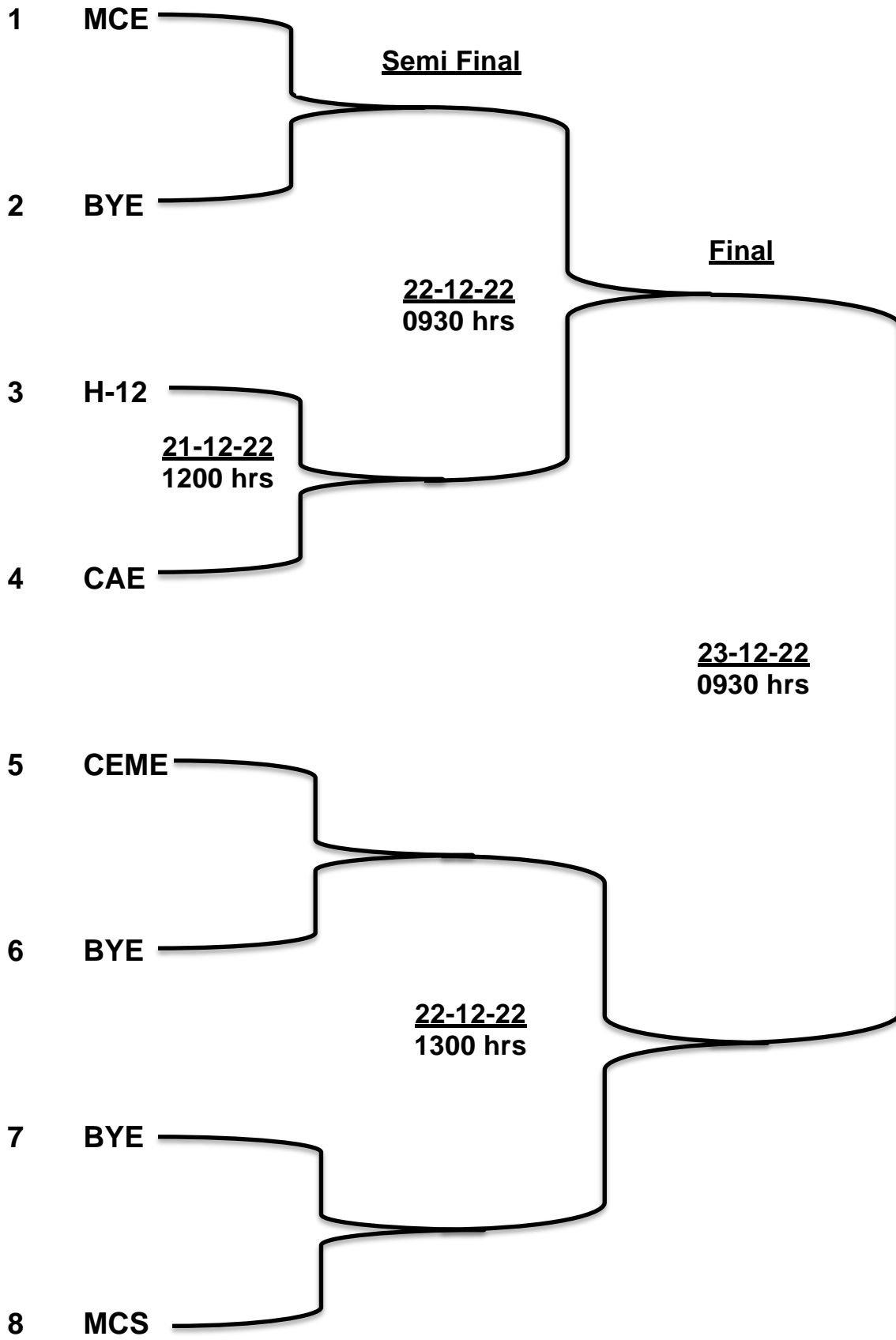
INTER COLLEGE CRICKET (MEN/WOMEN) COMPETITIONS- 2022/23

1. Inter College Cricket (Men/Women) competition will be played at H-12 Campus NUST, Islamabad. Men at HBL Cricket ground and women at NICE Cricket ground at H-12 Campus, Islamabad.
 2. All team managers /sports officers are responsible of their team discipline. Presence of team managers /sports officers is mandatory during competitions.
 3. Nominal Roll of the teams (format att) must be submitted before the match. The nominal roll must be vetted by CMS Coordinator, signed by the sports officer and counter signed and stamped by Registrar/Btn Cdr/DC Exams.
 4. The competition will start as per schedule attached and all teams must report at venue 15 minutes prior given time for the start of match.
 5. Team will be disqualified if not arrived within 5 minutes after given time for the start of match. Incomplete team will be disqualified.
 6. Teams will be comprised of 16 x players. 30 % strength of the team can comprise of Officers (Under 25).
 7. Men cricket matches will be played with hardball with T-20 rules. Max 4 overs per bowler and power play will be observed for 1st six overs.
 8. Women cricket will be played with Tennis Tape ball with 10 Overs. Minimum 5x bowlers will be used with maximum 2 overs each.
 9. Men cricket competition will be played on knock out basis and Women Cricket competition will be played on single league basis and winner will be declared on point basis. If the points are equal, then the Runrate will be calculated. If Runrate is also equal, then number of wickets will be calculated. All International rules will apply to Men Cricket competition No runs for Bye/Leg Bye in Women Cricket, Over throw runs will be counted.
 10. Men team will wear white cricket kit whereas, women will wear colored cricket kit.
 11. Referees decision will be final.
 12. Protest must be submitted in writing alongwith fee Rs 5,000/- within 15 minutes of termination of match. If the protest is valid and accepted, 100% of the fee will be refunded.
 13. No protest will be launched on the decision of referee. Protest if any launched, will be settled by the Jury of appeal at any stage during the course of competition.
