

GENERAL INSTRUCTIONS

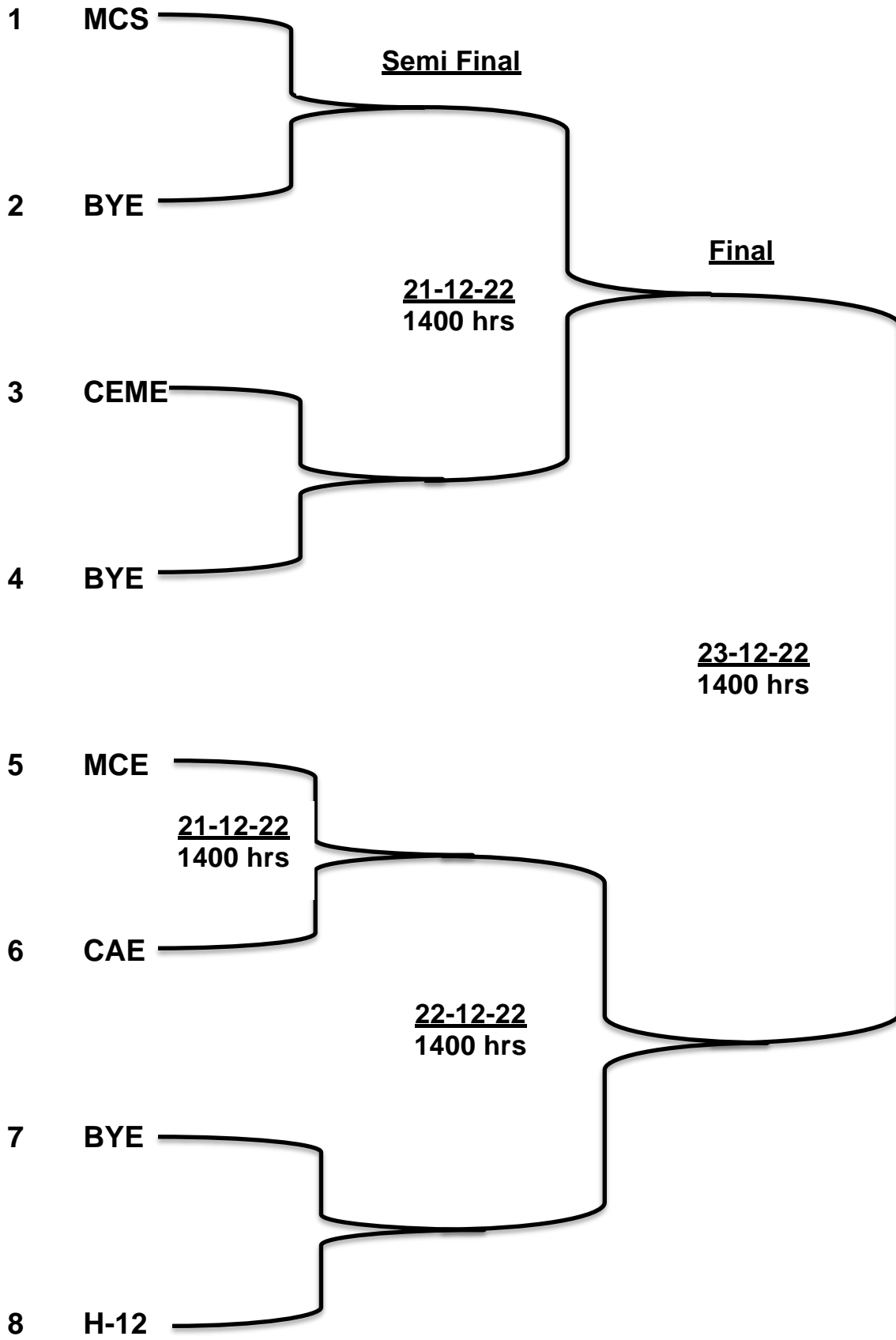
INTER COLLEGE FOOTBALL (MEN) & FUTSAL (WOMEN COMPETITIONS- 2022/23

1. All matches will be held at College of EME on knock out basis.
 2. Football ground dimension will be 100m x 60m.
 3. All team managers /sports officers are responsible of their team discipline. Presence of team managers /sports officers is mandatory during competitions.
 4. Nominal Roll of the teams (format att) must be submitted before the match. The nominal roll must be vetted by CMS Coordinator, signed by the sports officer and counter signed and stamped by Registrar/Btn Cdr/DC Exams.
 5. The competition will start as per schedule attached and all teams must report at venue 15 minutes prior given time for the start of match.
 6. Team will be disqualified if not arrived within 5 minutes after given time for the start of match. Incomplete team will be disqualified.
 7. Football (Men) team will be comprised of maximum 16 x players and minimum 11 players and Futsal (Women) team will be comprised of maximum 10x players and minimum 7x players. 30 % strength of the team can comprise of Officers (Under 25).
 8. All Football (Men) matches including final match will be played on 45 minutes each half, with 10 minutes break. In case of tie, extra time will be given of 20 minutes (10 min each half). If match is tied again, then 5x Penalty Shoots will be given to each team.
 9. All Futsal (Women) matches including final match will be played on 15 minutes each half, with 5 minutes break. In case of tie, 5x penalty shoots will be given to each team.
 10. Players must wear proper sports kits (Trouser, T -Shirt & Joggers for women and short, T-Shirt & jogger for Men) no Shalwar Qamez or any other dress is allowed.
 11. Referees decision will be final.
 12. Protest must be submitted in writing alongwith fee Rs 5,000/- within 15 minutes of termination of match. If the protest is valid and accepted, 100% of the fee will be refunded.
 13. No protest will be launched on the decision of referee. Protest if any launched, will be settled by the Jury of appeal at any stage during the course of competition.
