

**GENERAL INSTRUCTIONS**  
**INTER COLLEGES SQUASH (MEN/ WOMEN) COMPETITIONS- 2022/23**

1. Inter College squash (Men/Women) competition will be held at NUST Squash Court H-12 Campus.
2. Men squash competition will be held on knock out basis and Women squash competition will be played on single league basis and winners will be declared on point basis for women competition.
3. All team managers /sports officers are responsible for their team discipline. Presence of team manager is mandatory during competitions.
4. Nominal Roll of the teams (format att) must be submitted before the match. The nominal roll must be vetted by CMS Coordinator, signed by the sports officer and counter signed and stamped by Registrar/Btn Cdr/DC Exams.
5. The competition will start as per schedule attached and all teams must report at venue 15 minutes prior given time for the start of match.
6. Team will be disqualified if not arrived within 5 minutes after given time for the start of match. Incomplete team will be disqualified.
7. Team will be comprised of maximum 4 and minimum 3 players (Under-25 only). 30% strength of the team can comprise of Officers (Under 25).
8. All team managers /sports officers will submit list of team duly signed with their seeding before the start of tournament and once seeding given cannot be changed at any stage and will remain the same for all the matches.
9. Team event with best of three matches. Playing format will be that No-1 will play against No-1 of other team. No 2 will play against the No 2 of other team and No 3 will play against the No 3 of other team.
10. Each match will be played on best of three games with relay scoring system. Each game will be of 11 pts.
11. Players must wear proper sports kits (Trouser, T -Shirt & Joggers for women and short, T- Shirt & jogger for Men) no Shalwar Qamez or any other dress is allowed.
12. Trophies will be handed over through vouchers.
13. Referees decision will be final.
14. Protest must be submitted in writing alongwith fee Rs 5,000/- within 15 minutes of termination of match. If the protest is valid and accepted, 100% of the fee will be refunded.
15. Protest if any launched, will be settled by the Jury of appeal at any stage during the course of competition.

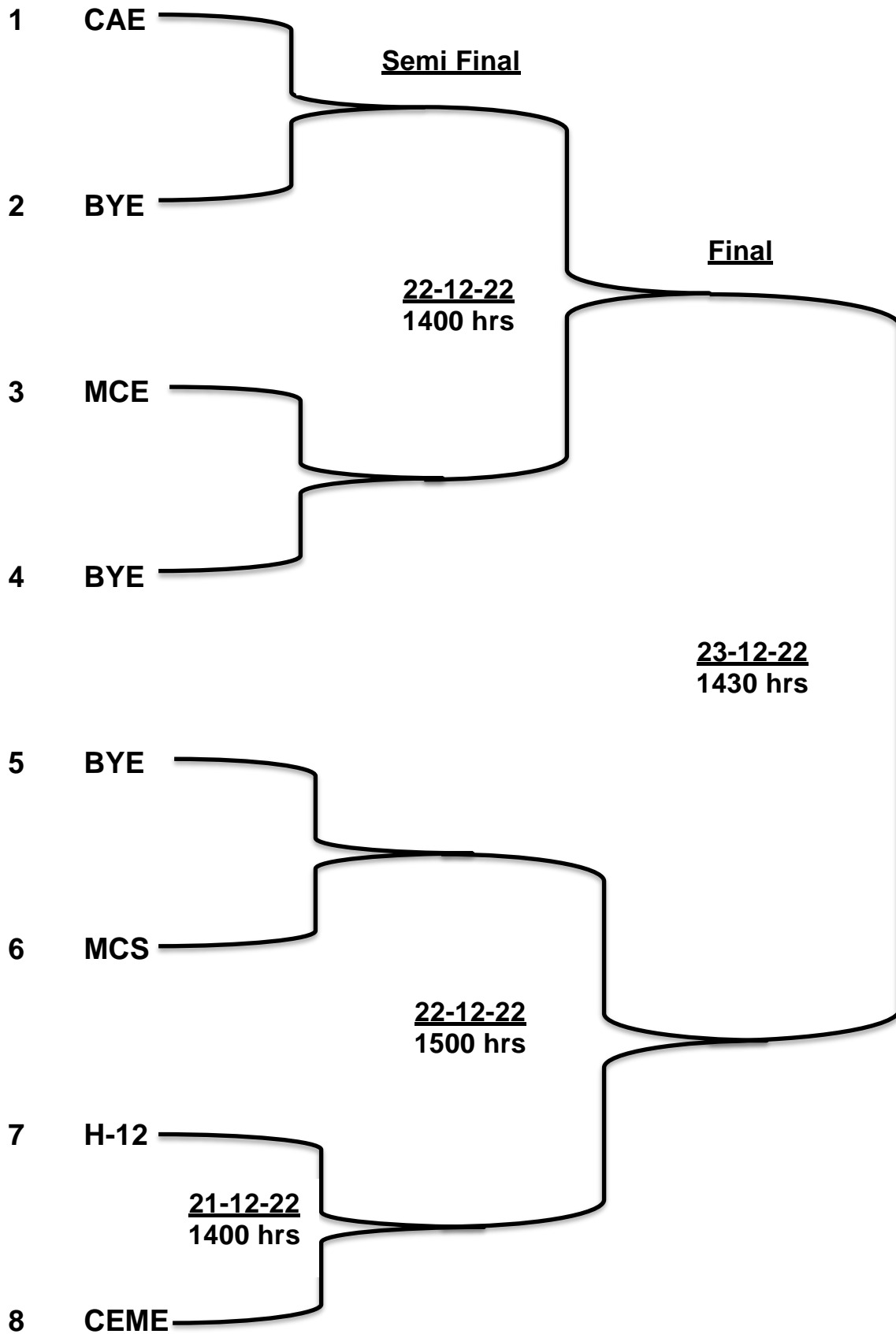
