## Maritime Politics-IR, 821 (Elective Course)

Course Description: Maritime Politics explores the intricate dynamics of maritime spaces, encompassing oceans, seas, and their surrounding regions. The course examines how states, international organizations, non-state actors, and maritime communities navigate issues of jurisdiction, security, economic development, environmental sustainability, and geopolitical rivalries in these critical areas. Through historical analysis, legal frameworks, case studies, and contemporary challenges, students will gain a deep understanding of the multifaceted dimensions of maritime politics and its implications for global governance.

<u>Course Objectives</u>: The course aims to introduce maritime security as a significant issue in international relations. Today's maritime domain overlaps multiple aspects like politics, economics, strategy, environment, and International Law (IL). The maritime features like reefs, archipelagos, straits, channels, and shoals can/might all act as critical choke points for different actors in specific contexts – threatening traditional and non-traditional security. This is why great powers are working towards enhancing their maritime capabilities; the maritime domain is significantly focused upon in their security and grand strategies.

**Learning Outcome**: By the end of the course, students will be apprised of all the above-mentioned themes. They will be familiarized with the key facets of strategic thought associated with the maritime realm. They will also debate how maritime security is vital to Pakistan's long-term prosperity and security.
